

Visa Processing Requirements For Bangladeshi Origin -Foreign Nationals

1. **TF Visa (One year validity).** Following documents to be submitted:
 - a. Printed copy of completed online visa application form.
 - b. Copy of Singapore IC / Employment Pass / Work Permit in Singapore.
 - c. Copy of Passport.
 - d. Copy of last visa page and last arrival page (if any).
 - e. Copy of previous Bangladesh Passport / Birth Certificate/ Educational Certificate from Bangladesh / Renunciation Certificate.
 - f. Copy of marriage certificate (for foreign spouse).
 - g. Copy of father's/mother's Bangladeshi passport / marriage certificate/renunciation certificate (for foreign children).
 - h. A period of 03-04 working days is required from the date of submission of the printed copy of visa application to the High Commission.

2. **No Visa Required (NVR) Seal (For new applicant).** Following documents to be submitted:
 - a. Printed copy of completed online NVR application form.
 - b. Copy of Singapore IC / Employment Pass / Work Permit in Singapore.
 - c. Copy of Passport.
 - d. Copy of previous Bangladesh Passport/Birth Certificate / Educational Certificate from Bangladesh/Renunciation Certificate.
 - e. Copy of marriage certificate (for foreign spouse).
 - f. Copy of father's/mother's Bangladeshi passport / marriage certificate/renunciation certificate (for foreign children).
 - g. Minimum 45 days will be required for getting the approval from Ministry of Home Affairs of Bangladesh.

h. Upon approval one set of the above mentioned document along with the delivery slip and passport to be brought for NVR seal.

j. A period of 03-04 working days is required for the NVR seal from the date of submission of the printed copy of NVR application to the High Commission.

3. No Visa Required (NVR) Seal (Transfer). Following documents to be submitted:

a. Printed copy of completed online NVR application form.

b. Copy of Singapore IC / Employment Pass / Work Permit in Singapore.

c. Copy of Passport.

d. Copy of previous NVR seal page.

e. A period of 03-04 working days is required from the date of submission of the printed copy of NVR application to the High Commission.

f. Fee - S\$95.00 Singapore dollars.

4. For Tourist/Visit Visa (T Visa).

a. Copy of IC / Employment Pass / Work Permit in Singapore.

b. Hotel booking receipt from Bangladesh / Sponsor letter/ letter of invitation from Bangladesh.

c. Air ticket booking receipt.

d. A period of 03-04 working days is required from the date of submission of the printed copy of visa application to the High Commission.
